

We live at across from the proposed garden centre at 6689

Goodmere Rd. We absolutely do not approve of the plan. When the beauty parlour was suggested, the owners explained that they were to have a residence there and the salon would be part of the building. Further, we were told that the clients would drive in at one side of the house, park at the back of the residence (waterside) and drive out on the other side (East side). That wasn't done nor has it been used as a residence. Instead, an extended area across the front of the house was put in place creating 4 parking spots. The salon has 10 employees, all have cars, and of course the clients have cars . They park all along Goodmere and anywhere else—regardless of ownership of properties involved. Making Goodmere through to Brownsey Way will only add to the problem. When there's a service or function at Trinity Church, Murray Rd., folks park on both sides of Murray. The two way traffic at times is very difficult. Hit & run accidents aren't uncommon. One can clearly understand, the plan for a garden centre, given the additional traffic it would bring, is not feasible. Very poor idea to say the least. As for us, we have difficulty now getting out of our drive. The addition of another business—no thanks!!!

As a neighbour in the vicinity of 6689 Goodmere Rd., I wish my support for this application to be recorded and shared with Council on April 25th. I only moved in January 22 and did not receive notification of this request for a variance although I can see the property in question from my front door and it is only one block away.

Pure Elements Hair Design and Bodyworks is a small woman-owned business that provides jobs as well as products and services for local people. It was the first business to begin to realize the Official Community Plan vision for this area, introducing a retail node adjacent to the downtown core.

Now Pure Elements wants to add Artisans Garden, an educational green house and garden centre emphasizing environmental values that include growing plants, selling art made from re-purposed items, and demonstrating rainwater catchment as mandated by the OCP. This will be the only garden centre in Sooke except for Home Hardware, and it will serve a slightly different niche market. I believe that the proposed additions enrich our neighbourhood, encouraging more pedestrians to visit, including the 31 households at Harbourside Cohousing, of which I am one. For those coming by car, two new parking spots are planned.

I support the requested variances to setbacks as they are only to accommodate a small greenhouse and a pedestrian walkway/deck. This will continue to be a quiet business and should add beauty as well as retail amenities and jobs to the neighbourhood.
