- 2. Approval of the Agenda: MOVED to approve the agenda as circulated. CARRIED
- Approval of the Minutes: MOVED to approve the minutes of May 21, 2015 as circulated. CARRIED

Committee Discussion:

- Additional community organizations with an interest in a proposed Community Centre have been invited to attend the SCACC meetings, as non-voting members.
- Clarification that each of the 15 member organization as outlined by the Committee Terms of Reference has one vote by its representative.

5. Information Roundtable:

- Sharing of new developments related to the Committee's mandate (eg. Seaparc Consultation Session)
- Review of <u>Getting it Built</u>
- Review of Sooke Seniors Drop-in Centre Visioning Document 2013

Committee Discussion – New Developments:

- SEAPARC has held its Open House on the SEAPARC Strategic Plan and it is hoped to have a DRAFT Strategic Plan prepared early in July. Steve Knoke gave a brief overview of the proposed expansion.
- Discussion of possible partnerships for future development

Committee Discussion - Getting it Built:

- There is no need to "reinvent the wheel" as there has already been lots of outreach completed.
- The items in "Getting it Built" are not the absolute or have to happen. These were the maximum needs that were expressed at the time the information was collected
- Discussion of whether these suggestions still make sense; the issues still seem to be the same but the spaces may have changed already.
- Possibility of senior's groups sharing space with youth groups. This has worked in the past.
- A coffee shop could be a social enterprise and youth could be trained to work there or it could be operated as a business; these would have to have to be looked at closely and have a business case as it most likely would not generate additional revenue and may only cover costs to operate a training program
- A lot of people spoke about having a welcoming environment, a place to be. This is identified as "lounge" space in the report.
- Concerns as to funding being a factor not able to provide or create public facilities for everything.
- Importance of breaking bureaucratic barrier first and making existing spaces more accessible.
- Arts group want a specific place where people can take part in creating art; look at a multi-purpose room for art
- Discussion as to the Regional Library Request for Proposal (RFP) and whether it has been issued yet. Important that the Committee be informed/updated as to the RFP
- Discussion as to performance space and whether it is this just a matter of making better use of existing space or whether there is a need for a new performance space. There are difficulties with Edward Milne due to costs etc. and it has become prohibitive. Look at using the Community Hall as long as it fits with the Community Hall schedule.
- There have been more demands on the Community Hall for performances; the Community Association can usually work around performances but rehearsal time becomes challenging as the Hall is usually booked in the evenings with sports groups.
- Discussion as to the proposed all-weather sports fields and whether it will alleviate some of the demand on the Community Hall.
- Comments as to a table tennis club for seniors and youth.
- Discussion as to groups not having access to the Edward Milne Community Theatre as the concept is that it should be used by the "community". Not having community access is a concern and these barriers need to be looked into
- Discussion as to the Community Theatre as a community space and the concerns as to the disconnect between the School Board who sets out the costs and the need for CUPE staff for the theatre facility, concerns that the community groups cannot meet these costs
- Discussion as to the changes in the community use of schools. The community built Edward Milne Community School is being used differently than what it is currently being used. It was supposed to be used by the community. Importance of the District of Sooke and the SCCAC to start advocating for the community use of

schools

- Discussion as to the community school being a non-profit, and whether they would be affected by asking for cut rates for community groups
- Importance of including SEAPARC and the Sooke Community Association in discussions with the Sooke Board.

MOVED to recommend to Council invite the Sooke School District #62 Superintendent and local school board members to an upcoming Sooke Community Centre Advisory Committee meeting in order to discuss community school access and how to break down the barriers to access. **CARRIED UNANIMOUSLY**

- Storage facilities are a need for many organizations. Currently the Community Hall has a lot of storage items in their basement. Discussion of alternate locations not in town centre, perhaps District of Sooke Public Works yard.
- Office space is another common need. Currently office space is being used in the basement of the Community Hall.
- Lounge space is defined as more of a gathering space, a place to be.
- Daycare/Preschool could be used as a revenue source. SEAPARC uses their multipurpose space now and feels there is demand to expand the program if additional space were available as it is highly sought after.
- Could engage the TELUS Community Grants organizational efficiency program to provide a review of community spaces and efficiencies.
- Some additional sources of funding or support to explore could include HEROWORKS, Western Financial grants through Coast Capital and VAN CITY grants.
- A functional use plan of the community hall could allow for youth and seniors to share space, as long as ground level and had a community kitchen.
- Discussion of new places vs. renovation of existing places. Committee is leaning towards improvement of existing places improving efficiencies and breaking down barriers to accessing existing places.

Committee Discussion – Sooke Senior's Drop In Visioning Report:

- A useful document for each group to look at. The Seniors Drop In Centre spent the time to outline their needs and also say what they are prepared to pay/give towards the creation of a space.
- The Sooke Community Arts Council did also complete a similar exercise and report.

Action Item: Staff to make sure the Sooke Community Arts Council report is made available.

Committee Discussion – Next Steps:

- This Committee needs to focus on putting together a plan of action, rather than collecting more open feedback.
- Discussion of possible site visits to locations where facilities might be considered.
- One thing that needs clarification is how open the Sooke Community Association is to reorganizing the space at the Community Hall, possible expansions etc.

MOVED to support the Sooke Community Association in holding a facilitated meeting to help strategize the functional use of the Community Hall **CARRIED**
