## BYLAW No. 541

A Bylaw to authorize the use of low-speed electric-powered vehicles on public highways.

The Council of the District of Sooke, in open meeting assembled, enacts as follows:

- 1. This Bylaw is cited as Bylaw No. 541, Low-Speed Electric-Powered Vehicle Authorization Bylaw, 2012.
- 2. In this Bylaw,
  - a) "Municipality" means the area contained within the geographical limits of the District of Sooke:
  - b) "neighbourhood zero emission vehicle" means a vehicle that travels on four wheels and is powered by an electric motor that is designed to allow the vehicle to attain a speed of 32 kilometres per hour but not more than 40 kilometres per hour in a distance of 1.6 kilometres on a paved level surface, and which
    - i) meets or exceed standards of the *Motor Vehicle Safety Act* (Canada) for a low-speed vehicle and bears a compliance label for a low-speed vehicle in accordance with that *Act*; or
    - ii) if imported to Canada, has been imported as an admissible lowspeed vehicle in accordance with the *Motor Vehicle Safety Act* (Canada) requirements and
      - (1) bears a compliance label for a low-speed vehicle in accordance with that Act; or
      - (2) meets applicable federal United States laws in accordance with the *Motor Vehicle Safety Act* (Canada).
- 3. A person may drive or operate a neighbourhood zero emission vehicle on any highway within the Municipality that has a speed limit of over 40 kilometres per hour but no more than 50 kilometres per hour.

- 4. A person who drives or operates a neighbourhood zero emission vehicle as authorized by this Bylaw may cross a highway that has a speed limit that is not greater than 80 kilometres per hour at an intersection to enable the person to continue on a highway on which the person is authorized to drive or operate a neighbourhood zero emission vehicle.
- 5. The authority conferred by Section 3 and Section 4 of this Bylaw is in addition to the authority under:
  - a) Section 24.06(2)(a) of the *Motor Vehicle Act Regulations*, B.C. Reg. 26/58, as amended, for a person to drive or operate a neighbourhood zero emission vehicle on a highway that has a speed limit of 40 kilometres per hour or less; and
  - b) Section 24.06(2)(c) of the *Motor Vehicle Act Regulations*, B.C. Reg. 26/58, as amended, for a person to drive or operate a neighbourhood zero emission vehicle in accordance with the provisions applicable to a "utility vehicle" as defined in the said Regulations, as set out in Section 24.03 of the said *Regulations*.
