## 1. Precedence

1. This Addendum shall form an integral part of the Work. This Addendum shall take precedence over all requirements of the RFQ Documents with which it may prove to be at variance unless otherwise qualified by the District.

## 2. Purpose

1. This Addendum is in response to enquiries related to the Request for Quote document, and is intended to make it easier and more fair for all bidders wishing to submit a quote.

## 3. Clarifications to the Scope of Work and General Conditions

2. The contract price will now be estimated as a **lump sum** rather than by unit rate of paint used. The locations of painting have not been changed, however the crosswalks have been tallied by number of bars, rather than by an estimated standard length. For ease of calculation, the works and locations listed in the RFQ document equate to:

13 Stop Bars (3.5m x 0.6m)

382 Zebra Stripe Bars (3.0m x 0.6m)

8 Turn Arrows

2 "No Stopping" "x's"
