#### **5. Memorial Project:**

To be carried forward as first item of discussion at January 2021 SPA Committee meeting.

- When committee members met on site, the discussion was that a structure at Quimper Park with memorial plaques along the bottom would be the best solution.
- Also discussed Ed Macgregor Park as possible location. The existing structures on site could use some restoration. Committee members encouraged to visit site.
- Separate the memorial project from any public art piece proposed by the committee.
- Discussion of possible public art piece at Quimper Park, overlooking the spit, potentially next to and complementing a memorial structure.
- Archeological and environmental considerations, dependent on location.
- Susan, Lorraine, Jessica Boquist, Dana interested in forming working group.

#### **6. Prioritization of SPA Committee projects – Ideas Board**

Outstanding project ideas for initial discussion:

1. District Art Inventory
  - An inventory of municipally owned art was completed in 2017.
  - Sent to committee by Montana.
2. Murals
  - Lorraine has downloaded a mural kit from city of Victoria.
  - Lorraine to do research and find out more about our public art and considerations for exterior art.
  - Mural from side of Mom's Café currently being stored in the public works yard. It is in decent condition but likely needs some restoration work.
  - Will need to determine original artist and seek permission to restore, if possible.
  - Montana and Lorraine to form working group for murals and conduct further research.
3. Communities in Bloom (CiB)
  - History of SPA Committee participation in Communities in Bloom. In 2019, each SPA member was assigned a topic and asked to write a summary for the Profile Book.
  - Judges' tour was very informative. Would be nice to do something similar with SPA Committee post-COVID.

- A map of public art could also be made available for committee members to tour themselves.
  - Clarification that CiB participation requires Council support and financial resources.
  - Idea to line highway with dogwoods.
  - Sarah to send CiB 2019 profile book and photo album to committee members.
  - BC Communities in Bloom likely to make announcement in early 2021 regarding program.
4. Community Arts Bulletin – Evergreen Kiosk
- Previous SPA Committee discussed using this as a centralized location for posters.
  - The District has a license of occupation to use this area for tourism promotion. Would need to be renegotiated to change the use.
  - A new wooden kiosk in John Phillips Memorial Park can have posted attached to the back of it. Plan for more of these in local parks.
  - Once library constructed, Lot A will be a good location for centralized promotion of events.
  - Put on hold for future consideration.
5. Felt Fish Sculpture
- History of the sculpture. Was commissioned for 2010 Olympics, relocated to the Sooke Harbour House, has since spent some time outdoors.
  - Bev Petow was metal artist involved. Dana and Lorraine to speak with Bev to discuss restoration possibilities.
  - Laura to organize a time for interested parties to view the fish at the public works yard.
  - Lorraine, Dana, Peter, Susan interested in attending.
6. Whiffin Spit Sea Can
- Future of the sea can is uncertain currently. May be relocated.
  - Remove from list of projects.

Additional new projects for consideration:

1. Painting of Sooke Bridge
- Local resident contacted Council asking for advocacy assistance. Provincial Ministry of Transportation (MoT) owns the bridge and they suggested if a local group wanted to make suggestions on behalf of the community regarding the painting of the bridge, they might entertain ideas.
  - MoT has regular bridge maintenance schedule. Details of when the Sooke River bridge might be painted next are not available.
  - Environmental considerations involved in painting the bridge include hazardous materials in current paint and proximity to salmon-bearing river.
  - Possibility of lighting up bridge.
  - New dark skies initiatives may prevent addition of lights.

- Lorraine, Peter, JP to research and make suggestions.

1. Oak Bay Sculptures
  - Additional information sent out by Gregory.
  - Possibility of making Sooke map with public art locations.
2. Crosswalk
  - Laura to do report on costs, expected longevity, maintenance considerations.

3. Totem Pole
  - No additional info regarding preferred placement of possible totem pole donation.
