## **Council Procedure Amendment Bylaw No. 833**

#### **RECOMMENDATION:**

THAT Council give First, Second and Third Reading to "Council Procedure Amendment Bylaw No. 833 (728-03), 2021".

#### **Previous Council Action:**

At the October 25, 2021 Regular Council meeting, the following resolution was passed: THAT Council direct staff to bring forward an amendment to section 10(3) of the Council Procedure Bylaw to permit 4 members of Council, physically unable to attend in person, to attend meetings electronically at any one time.

AND THAT staff be directed to bring this regulation back to Council with full consideration of electronic meetings.

#### Report:

During the COVID-19 pandemic, gatherings were restricted under provincial health orders. As a result, the Province authorized electronic Council meetings under Order M192 so that business could continue. Order M192 expired on September 28, 2021 but an amendment to the *Community Charter* that into effect on September 29, 2021 now provides permanent authority for electronic meetings as long as they are authorized by the municipality's Council Procedure Bylaw.

Staff are awaiting an update to the electronic meeting best practices from the Province. Once received, the issue as a whole, will be brought forward for Council consideration. In the interim, Council has directed staff to bring forward an amendment to increase council member electronic participation to a maximum of four (4). Under the current bylaw, only one member of council may participate electronically.

The draft amendment bylaw is attached for consideration.

#### Legal Impacts:

In accordance with section 124(3) of the *Community Charter*, notice will be provided regarding the proposed amendment prior to adoption for two consecutive weeks.

## DISTRICT OF SOOKE COUNCIL PROCEDURE AMENDMENT BYLAW NO. 833

A bylaw to amend the "Council Procedure Bylaw No. 728, 2019" to increase the number of Council members that may attend electronically.

The Council of the District of Sooke, in open meeting assembled, enacts as follows:

#### Citation

1. This Bylaw is cited as the "Council Procedure Amendment Bylaw No.833 (728-03), 2021".

#### Amendments

- 2. Section 10 is hereby amended by deleting subsection (3) and replacing it with a new subsection (3) as follows:
  - "(3) No more than four (4) Members of Council, physically unable to attend in person, may participate at a meeting under subsection 1(a) at any one time."

READ a FIRST, SECOND and THIRD time the 8 day of November, 2021.
