#### **MAIL BALLOT VOTING**

### **REQUESTING A MAIL BALLOT PACKAGE:**

No earlier than September 21, 2022 and before 4 pm on October 13, 2022 you must submit the following information to the District office by mail (2205 Otter Point Road, Sooke, BC, V9Z 1J2), fax (250-642-0541) or email (stemple@sooke.ca):

- (1) Full name,
- (2) Residential address,
- (3) Address of the property in relation to which you are voting (for non-resident property electors),
- (4) Method of delivery of your mail ballot package:
  - pick up at District office, OR
  - regular letter mail through Canada Post to residential address, OR
  - regular letter mail through Canada Post to an alternate address that you provide when requesting the ballot package, and
- (5) If you are not on the list of electors, to ensure you receive the correct registration application form in your package, you must indicate whether you are going to be registering as a resident or non-resident property elector.

Ballots will be mailed or available for pickup at the Municipal Hall beginning on October 5, 2022. To be counted, your mail ballot must be received by the Chief Election Officer no later than 8 pm on Saturday, October 15, 2022.

#### **ELECTOR REGISTRATION**

**If you are not on the list of electors**, you may register at the time of voting by completing the required application form available at the voting place. To register you must meet the following qualifications:

To register as an elector you must:

- be 18 years of age or older on general voting day;
- be a Canadian citizen;
- be a resident of British Columbia for at least 6 months immediately before the day of registration (at time of voting);
- be a resident of the District of Sooke on the day of registration (at time of voting); or be a registered owner of real property in the District of Sooke for at least 30 days immediately before the day of registration (at time of voting);
- not be disqualified under the Local Government Act or any other enactment from voting in an election or assent voting and not otherwise disqualified by law.

**Non-resident property electors** must also produce **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, provide **written consent** from the other property owners.

## TYPES OF DOCUMENTS THAT WILL BE ACCEPTED AS IDENTIFICATION

**To register, resident electors** must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity. The following classes of documents will be accepted:

- a) a Driver's Licence;
- b) an Identification Card such as a photo BC services card or a non-photo BC services card;
- c) an Owner's Certificate of Insurance and Vehicle Licence issued by ICBC
- d) a BC CareCard or BC Gold CareCard;
- e) a Ministry of Social Development and Economic Security Request for Continued Assistance Form SDES8, (now "Monthly Form EA181);
- f) a Social Insurance Number card;
- g) a Citizenship Card;
- h) a real property tax notice;
- i) a credit card or debit card; or
- j) a utility bill, (such as electricity, natural gas, water, telephone or cable services).
