- A diploma in Civil Engineering Technology or equivalent.
- Must be able to obtain and maintain registration as an Applied Science Technologist (AScT) in BC.
- A minimum of two (2) years' related engineering experience.
- A valid Class 5 BC Driver's Licence and a current Driver Abstract.
- A satisfactory Police Information Check.

Additional consideration may be given to applicants with the following qualifications:

- Project Management Professional (PMP) certification.
