Victoria Regional Transit


Overall System Scope:

- Second largest system in BC
- 100,000 passenger trips per day
 - 6.5% share of all trips in the region
 - Fixed route & Custom (handyDART)
- Carries more people per hour at lower cost per hour than Canadian peers

By the Numbers:


- Fixed route system 281 buses
- HandyDART service 54 buses
- 930,000 service hours annually
 - 550 Transit Operators
 - 100 Mechanics and service people
 - 33 Dispatch, customer service and other
 - + others shared with BC Transit's provincial operations
- 56 routes with 2,300 bus stops

Victoria Regional Transit Commission



- Established under the *BC Transit Act*
 - » Local government representation for transit services in the Capital Regional District
- Seven elected local government officials appointed
- Chair designated by Minister responsible for BC Transit
- BC Transit Act: appointment process, composition, term
- Staff, resources and contracted services provided by BC Transit
- The role of the Commission is to approve routes, service levels, budget, fares and taxation rates
- Commission has sent a request to the Minister for an additional Commission Member from the Westshore
- Across B.C.: variety of governance models in place



Existing Sooke Services


- Served by three existing transit routes:
 - Route 61 Sooke/Downtown with regional connections to the Westshore and Downtown Victoria
 - Local community bus routes 63
 Otter Point and 64 East Sooke
 which provide service to East
 Sooke, Sunriver and Kemp Lake Rd.
- Morning peak transit mode share:
 - 15% average for Sooke
 - 9% average for region
- Midday average transit mode share:
 - 1% for Sooke
 - 6% for region












Recent Service Improvements in Sooke

- 61 Sooke Fall 2014 additional Saturday night trip to/from Sooke that connects to downtown Victoria
- 64 East Sooke Summer 2015 changed routing to SEAPARC Leisure Complex
- Under the Transit Shelter Program **five** shelters have been added since 2010.







Transit Future Plan

The Transit Future Plan provides a 25 year vision for transit in the region that:

- Supports municipal land use and transportation plans
- Supports CRD Regional Growth Strategy and Travel Choices (10 per cent transit mode share by 2026)
- Supports the achievement of the Provincial Transit Plan mode share target (12 percent by 2030)
- Prioritizes and plans for future service and infrastructure growth & needs
- The plan was endorsed by the Transit Commission and local governments




2006 ORIGIN / DESTINATION BY MUNICIPALITY - SOOKE

 8% of trips are to Langford and Colwood 2038





 - Review included consultation to help establish service improvement priorities











Medium-Term - Infrastructure


 Work with local government to determine the location for additional Park & Ride and a future transit exchange to ensure alignments with Town Centre development





Douglas Transit Priority

- BC Transit has partnered with the Transit Commission to provide the Transit Shelter Capital Upgrade Program to improve transit stops throughout the region.
- BC Transit staff would like to work with municipal staff to determine priorities over the next 3 years
