The participating dignitaries and the Council-Elect were led into the theatre by a piper followed by two RCMP constables and two members of the Sooke Fire Department.

Meeting was called to order by David Gawley, Interim Administrator.

Mr. Gawley, Interim Administrator introduced the Master of Ceremonies, Mr. Rick Kasper, MLA, Malahat/Juan de Fuca.

The Master of Ceremonies introduced The Honourable Jim Doyle, Minister of Municipal Affairs. The Minister of Municipal Affairs then gave an opening address to the assembled guests and Council-Elect.

The Master of Ceremonies introduced The Reverend Peter Norman, Holy Trinity Church of Sooke, who gave an invocation by offering a blessing on the new District, followed by a blessing on the new Council.

The Master of Ceremonies introduced Justice of the Peace, Her Worship Kerry Fedosenko who administered the "Oath of Office" and the "Oath of Allegiance" to the following:

The Mayor and Councillors each proceeded to take their chairs of office.

The Minister of Municipal Affairs thanked Justice of the Peace, Her Worship Kerry Fedosenko and then presented to Mayor Macgregor the official Letters Patent incorporating the District of Sooke, along with a

cheque in the amount of \$600,000 for the first installment of the special incorporation grant, a cheque in the amount of \$9,205 representing for the 1999 portion of the Small Communities Protection Grant and a gift from the Province of British Columbia of a commemorative gavel, water pitcher and water goblets.

Mayor Macgregor accepted the Letters Patent, cheques, gifts and extended thanks on behalf of the Council and the people of Sooke for the Province's help in the arduous process of incorporating the District of Sooke.

Mayor Macgregor then assumed the Chair. He welcomed the honoured guests and citizens to the first Inaugural Meeting of the District of Sooke.
